- Vehicle must have originally been sold as MINI Certified Pre Owned on or after January 1, 2014.
- At time of proposed transfer, the MINI Certified Pre Owned Limited Warranty must be in effect, that is, the vehicle is within age & mileage limits.
- Vehicle must not have been totaled, stolen, exported from the US, or imported to the US from another country.
- The MINI Certified Pre Owned Limited Warranty is only eligible to be transferred from private owner to private owner.
